#### **RULE 6.5 - PARENTING CLASS INFORMATION**

#### Dear Parent:

You are presently a party to an action in the Common Pleas Court of Van Wert, Ohio involving the custody and visitation of your children. As such, you are <u>required</u> to complete one parenting class pursuant to Van Wert Common Pleas Local Rule 6.5. Parenting programs are designed to assist you as a parent to resolve issues that may arise in your relationship with your ex-spouse and your children.

If you do **not** attend a parenting class, the Court will either deny you any custody or visitation right with your children or dismiss the case. The Court could also find you in Contempt for failing to abide by a binding Order, resulting in the levy of Fines and Court Costs as sanctions for Contempt. In the extreme, the Court could impose terms of incarceration for repeated infractions of Rule 6.5.
